### A BILL ENTITLED

1 AN ORDINANCE concerning: Public Works – Watershed Protection and Restoration  
2 Program – Stormwater Remediation Fee

3  
4 FOR the purpose of increasing the stormwater remediation fee; providing the method by  
5 which the stormwater remediation fee is set in subsequent fiscal years; repealing a  
6 certain obsolete provision; providing for the effective date of this Ordinance; and  
7 generally relating to the stormwater remediation fee.

9 BY repealing and reenacting, with amendments: § 13-7-103(b)  
10 Anne Arundel County Code (2005, as amended)

11  
12 BY repealing: § 13-7-103(o)  
13 Anne Arundel County Code (2005, as amended)

14  
15 BY renumbering: §§ 13-7-103(p) and (q) to be §§ 13-7-103(o) and (p), respectively

17 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
18 That § 13-7-103(o) of the Anne Arundel County Code (2005, as amended) is hereby  
19 repealed.

21 SECTION 2. *And be it further enacted,* That §§ 13-7-103(p) and (q) of the Anne  
22 Arundel County Code (2005, as amended) are hereby renumbered to be §§ 13-7-103(o)  
23 and (p) respectively.

1 SECTION 3. *And be it further enacted*, That Sections of the Anne Arundel County

8 **13-7-103. Stormwater remediation fee.**

9  
10 (b) **Base rate.** The base rate of the stormwater remediation fee for one equivalent  
11 residential unit shall be [~~\$85~~] \$89.25 per year. FOR THE FISCAL YEAR BEGINNING JULY 1,  
12 2020, AND FOR EACH FISCAL YEAR THEREAFTER, THE COUNTY EXECUTIVE SHALL SET THE  
13 STORMWATER REMEDIATION FEE AT A RATE SUFFICIENT TO MEET THE PURPOSES SET  
14 FORTH IN § 4-11-119(C) OF THIS CODE AND MAY INCREASE THE FEE IN AN AMOUNT NOT TO  
15 EXCEED 5.00% OF THE THEN CURRENT FEE. ANY INCREASE IN AN AMOUNT GREATER THAN  
16 5.00% SHALL BE SET BY THE COUNTY COUNCIL BY ORDINANCE.

18 SECTION 4. *And be it further enacted*, That this Ordinance shall take effect on July 1,  
19 2019.
